



HEALTH PROFESSIONS COUNCILS OF NAMIBIA (HPCNA) NOTICE

INCREASE IN FEES PAYABLE TO COUNCILS BY HEALTHCARE PRACTITIONERS

1. Councils would like to inform all healthcare practitioners about the increase in fees payable to the Councils with effect from the 9th of December 2020.
2. The increments are as follows:
 - a. **Allied Health Professions Council, Medical and Dental Council;**
 - Annual fee for maintaining registration: 3.43% increase
 - Fees relating to examination or evaluation: 3.43% increase
 - Fees relating to education, tuition or training: 3.43% increase
 - Fees relating to registration: 3.43% increase
 - Fees relating to continuing professional development: 3.43% increase
 - Fees relating to Lodging of a notice of appeal: fees revised
 - Other fees: 3.43% increase
 - b. All fees payable to the **Social Work and Psychology Council** increased with 6%.
 - c. **Nursing Council and Pharmacy Council** fees remain unchanged

ANNUAL MAINTENANCE FEES PAYABLE TO COUNCILS BY HEALTHCARE PRACTITIONERS

1. All registered and enrolled healthcare practitioners are being reminded to pay the prescribed annual maintenance fee for registration with their respective Health Professions Councils in Namibia for the period of 1st April 2021 to the 31st of March 2022 before the 31st March 2021.
